

THE CORPORATION OF THE MUNICIPALITY OF MARMORA AND LAKE

BY LAW NO. 2001-26

Being a By-law to regulate and licence exhibitions held for hire or gain within the Municipality of Marmora and Lake.

WHEREAS the corporation of the Municipality of Marmora and Lake considers it to be in the public interest that exhibitions held for hire or gain within the Municipality of Marmora and Lake be licenced and regulated;

AND WHEREAS The Municipal Act R.S.O. 1990, C.257 authorizes and enables the passing of By-laws for such purposes;

NOW THEREFORE the Council of the Municipality of Marmora and Lake enacts as follows:

1. In this By-law
 - (a) “exhibitions held for hire or gain” shall, without limiting the meaning of the term, be deemed to include concerts, musical exhibitions and festivals, and other gatherings which supply entertainment to persons in attendance and for which an admission or other price or fee is charged, whether directly or indirectly, but shall be deemed not to include any concert, dance entertainment or other exhibition which is held entirely indoors within an enclosed hall, arena or theatre;
 - (b) “person” shall include any corporation, organization or association and the singular shall include the plural;
 - (c) “Council” shall mean the Council of the Municipality of Marmora and Lake.
 - (d) “exhibition” shall mean an exhibition held for hire or gain.
2. No person shall hold, put on or conduct an exhibition held for hire or gain within the Municipality of Marmora and Lake unless such person has at least 30 clear days prior to the first scheduled date of such exhibition obtained from Council a licence authorizing the holding of such exhibition.
3. No person shall permit any land over which such person has control to be used for an exhibition held for hire or gain unless such exhibition has been authorized by a licence issued pursuant to the provisions of this by-law.
4. Application for a licence under this by-law shall be made to Council at least 60 clear days prior to the first scheduled date of the exhibition for which such licence is sought and receipt of written application by the Clerk of the Municipality of Marmora and Lake shall be deemed to be receipt by the Council.

5. (a) An application for a licence under this by-law shall be accompanied by particulars of the proposed exhibition, including the following:
 - (i) location;
 - (ii) dates and times;
 - (iii) the type of entertainment being offered;
 - (iv) the staging of the exhibition, including anticipated noise levels;
 - (v) the facilities available to accommodate the persons in attendance, including parking facilities;
 - (vi) policing and security arrangements, including arrangements for traffic control;
 - (vii) facilities and arrangements for the handling of food;
 - (viii) medical, washroom and sanitary facilities;
 - (ix) facilities and arrangements for garbage disposal and recycling;
 - (x) details of anything of a problematic nature which is expected to occur, or possibly occur in connection with or as a result of the exhibition and being in the nature of a matter falling within the proper concern of Council.
 - (b) the particulars provided by the applicant shall be in sufficient detail and contain sufficient information to enable Council to determine the adequacy of the facilities, provisions and arrangements proposed by the applicant;
 - (c) Council may require the applicant to provide further or other details or information.
 - (d) Notwithstanding the provisions of Section 6 of this By-law, Council may require, as a condition precedent to the issuance of such licence, that the applicant provide a bond or other security in such form and amount as it considers sufficient to indemnify the Municipality of Marmora and Lake for all costs, claims and expenses which it may incur in connection with or as a result of the holding of such an exhibition;
 - (e) The applicant shall pay to the Municipality of Marmora and Lake a fee for any such licence in the amount of One Hundred(\$100.00) dollars for each event to which the licence applies.
6. (a) Any licence issued by the Council pursuant to this by-law shall be deemed to

authorize only the holding of the exhibition for which application was made, in accordance with the particulars provided to Council,

- (b) Notwithstanding any other provision of the by-law, Council may specify or limit the hours during which any such licence shall be in effect and the licence shall have no wider scope or authority.
7. Any person who contravenes any of the provisions of this by-law is guilty of an offence and shall, upon conviction thereof, forfeit and pay a penalty of not more than Five Hundred (\$ 500.00) Dollars, such penalty to be recoverable pursuant to the provisions of The Provincial Offences Act, RSO 1990 CH.P.33
 8. Should any section, clause, provision or part of this by-law be declared by a court of competent jurisdiction to be invalid, the same shall not effect the validity of this by-law as a whole, nor any part thereof, other than the part so declared invalid.

THIS BY-LAW SHALL COME INTO FORCE AND TAKE EFFECT IMMEDIATELY ON AND AFTER THE PASSING THEREOF.
